Dear Ms. Mieles:

On November 18, 2024, Endurance Specialty Insurance Ltd. (“Endurance Specialty”) submitted a passport application for continued reciprocal jurisdiction reinsurer status in California pursuant to California Insurance Code (“CIC”) §922.425. Endurance Specialty is domiciled in Bermuda, and regulated by the Bermuda Monetary Authority. Endurance Specialty’s lead state for reciprocal jurisdiction reinsurance is Delaware.

On July 18, 2024, the Delaware Department of Insurance issued a letter approving Endurance Specialty’s application for reciprocal jurisdiction reinsurer status, effective January 1, 2025 to December 31, 2025. Based on the California Department of Insurance’s review of the application, and in reliance on the facts and representations contained therein, the Commissioner defers to the determination made by the Delaware Department of Insurance. Endurance Specialty is granted renewal of its reciprocal jurisdiction reinsurer status in California, effective January 1, 2025 to December 31, 2025, and cessions to Endurance Specialty by California domestics will be granted credit in accordance with CIC §922.425.

Endurance Specialty’s status as a reciprocal reinsurer is contingent upon Endurance Specialty maintaining full compliance with CIC §922.425, as well as timely, electronic submission of its renewal application. Endurance Specialty’s reciprocal reinsurer status must be renewed annually. The renewal application should be submitted to CAB-SF-Intake@insurance.ca.gov, once Endurance Specialty has received approval of its renewal application in Delaware, but no later than December 1, 2025.
